Selection Committee for the election of Rector of the International University of Sarajevo is appointed consisting of:

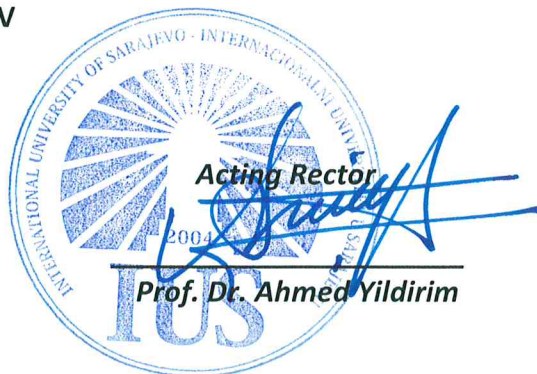
1. Prof. Dr. Sencer Yerelan,
